Member Tip of the Month

If someone claims they can get lost crypto funds back for a fee, stop immediately. Legitimate recovery professionals do not charge upfront. Encourage anyone affected to report through the Canadian Anti-Fraud Centre at 1-888-495-8501.

Crypto “Recovery Agent” Scams: A Growing Threat

A troubling new fraud trend is targeting Canadians who have already lost money to cryptocurrency scams. Called “recovery scams,” these schemes promise to retrieve lost crypto funds — for a fee — but ultimately cost victims even more.

The Canadian Anti-Fraud Centre (CAFC) reports that crypto recovery fraud increased by over 40% in 2024, with losses exceeding \$3.3 million. Fraudsters typically contact victims by email, text, or social media claiming to be “blockchain investigators,” “asset recovery specialists,” or even government agencies. They may present professional-looking documents or say they’ve “located” missing funds.

The catch: victims must pay upfront fees, often described as legal costs, taxes, or transfer charges. Once paid, communication stops and no funds are ever recovered.

Warning signs include:

- Requests for advance payment
- Claims of urgent deadlines
- Instructions to keep communications confidential

Provincial securities regulators are clear: legitimate agencies do not charge fees to retrieve lost investment funds.

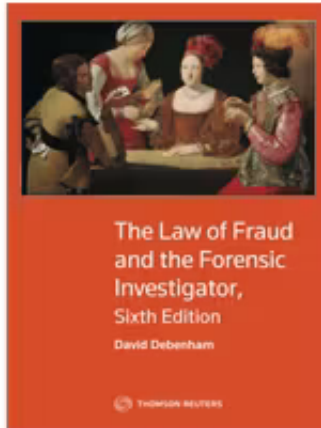
